Motion: Councilman Jahn moved to issue final warnings to applicable property owners. Motion seconded by Councilwoman Taylor. **Motion carried unanimously.**

D. Arvig Managed Services Proposal

Motion: Councilwoman Taylor moved to approve Arvig's proposal for managed IT services. Motion seconded by Councilman Paul. **Motion carried unanimously.**

E. Building Permit – McKenzie Taylor

Motion: Councilman Jahn moved to approve the building permit submitted by McKenzie Taylor. Motion seconded by Councilman Paul. **Motion carried.** (Councilwoman Taylor abstained.)
