#### 1791.06 Kennels

#### § 1791.06 KENNELS.

Section 91.06 of the Minnesota Basic Code, regarding the number of dogs comprising a kennel, is amended as follows.

(A) *Definition of kennel.* The keeping of four or more dogs on the same premises, whether owned by the same person or not and for whatever purpose kept, shall constitute a “kennel”; except that a fresh litter of pups may be kept for a period of three months before that keeping shall be deemed to be a “kennel.”

(B) *Kennel as a nuisance.* Because the keeping of four or more dogs on the same premises is subject to great abuse, causing discomfort to persons in the area by way of smell, noise, hazard, and general aesthetic depreciation, the keeping of four or more dogs on the premises is hereby declared to be a nuisance and no person shall keep or maintain a kennel within the city.

Step 1: A member or members of the city council will speak with you 1 on 1 about the Violation and come up with solutions to abate the violation, and a time from when the item shall be completed. A \$25.00 Fine shall be waived for the first occurrence.

Step 2: A written notice, sent by certified mail will be sent regarding the violation and a date in which it shall be corrected. As \$50.00 fine shall be assessed to the citizen.

Step 3: You will be placed on the city council agenda to appear before the city council to explain why the violation hasn't been resolved. A \$100.00 fine shall be assessed to the citizen.

Step 4: Criminal Prosecution in accordance with the Vesta City Code, which will result in further fines, court costs, legal fees and/or a petty misdemeanor or misdemeanor criminal charge.

\*all fines shall be paid to the City Clerk's office withing 14 days or a 1.5% interest fee shall be assessed for each 30 days thereafter. Any fines unpaid by October 31<sup>st</sup> will be assessed to property tax.



**WHEREAS**, under the state's Open Meeting Law, public policy discussions and decisions must occur in meetings that are accessible to members of the public; and


**WHEREAS**, cities are often laboratories for determining public policy approaches to the challenges that face residents and businesses; and


